

INDEKS HARGA PENGGUNA (IHP), JULAI 2017

1. Indeks Harga Pengguna (IHP) bagi bulan Julai 2017 meningkat sebanyak 0.3 peratus tahun-ke-tahun berbanding bulan Julai 2016. Indeks Makanan dan Minuman Ringan dan Indeks Bukan Makanan masing-masing mencatatkan peningkatan sebanyak 0.7 peratus dan 0.2 peratus tahun-ke-tahun.
2. Peningkatan IHP bagi bulan Julai 2017 sebahagian besarnya disebabkan oleh peningkatan Indeks Pangangkutan (1.4 peratus); Makanan dan Minuman Ringan (0.7 peratus); dan Perhubungan (1.3 peratus). Ini adalah berikutan harga yang lebih tinggi pada Indeks Pangangkutan bagi kenderaan, basikal dan tiket penerbangan. Manakala kenaikan harga Indeks Makanan dan Minuman Ringan adalah disebabkan oleh kenaikan harga bagi beras dan bijirin, daging, ikan dan makanan laut, minyak dan lemak, produk makanan lain serta air mineral, minuman ringan, jus buah-buahan dan sayur. Indeks Perhubungan yang lebih tinggi adalah disebabkan oleh peningkatan harga pada barang telefon dan telefaks.
3. Bagi perubahan tempoh ke tempoh, IHP bagi Januari-Julai 2017 mencatatkan penurunan sebanyak 0.3 peratus berbanding dengan tempoh yang sama tahun sebelumnya. Indeks Makanan dan Minuman Ringan dan Indeks Bukan Makanan masing-masing mencatatkan penurunan sebanyak 0.6 peratus dan 0.3 peratus.
4. IHP mengukur perubahan harga barang dan perkhidmatan yang dibayar oleh pengguna dalam satu tempoh masa ditetapkan dan dikumpulkan setiap bulan. Senarai barang dan perkhidmatan dalam IHP adalah berdasarkan maklumat perbelanjaan purata sebuah keluarga yang diperolehi melalui Kajian Perbelanjaan Keluarga. CONSUMER PRICE INDEX (CPI), JULY 2017

1. *Consumer Price Index (CPI) in July 2017 increased by 0.3 per cent year-on-year compared to July 2016. Both Food & Non-Alcoholic Beverages and Non-Food Index increased by 0.7 per cent and 0.2 per cent year-on-year, respectively.*
2. *The CPI increase in July 2017 was mainly attributed to increase in the indices of Transport (1.4 per cent); Food and Non-Alcoholic Beverages (0.7 per cent); and Communication (1.3 per cent). These were mainly due to higher prices of the Transport Index for motor car, bicycles and air tickets. Meanwhile, higher Food and Non-Alcoholic Beverages Index was due to increase in the prices of rice and cereals, meat, fish and seafood, oil and fats, other food products as well as mineral waters, soft drinks, fruit and vegetable juices. Higher Communication Index was due to higher prices of telephone and telefax equipment.*
3. *On a period-on-period basis, CPI in January-July 2017 has decreased by 0.3 per cent compared to the same period last year. Both Food and Non-Alcoholic Beverages and Non-Food Index decreased by 0.6 per cent and 0.3 per cent, respectively.*
4. *CPI is a measure of price changes of goods and services paid by the consumer in a specified period and compiled on a monthly basis. The list of goods and services in the CPI is based on the average expenditure per household from the Household Expenditure Survey.
