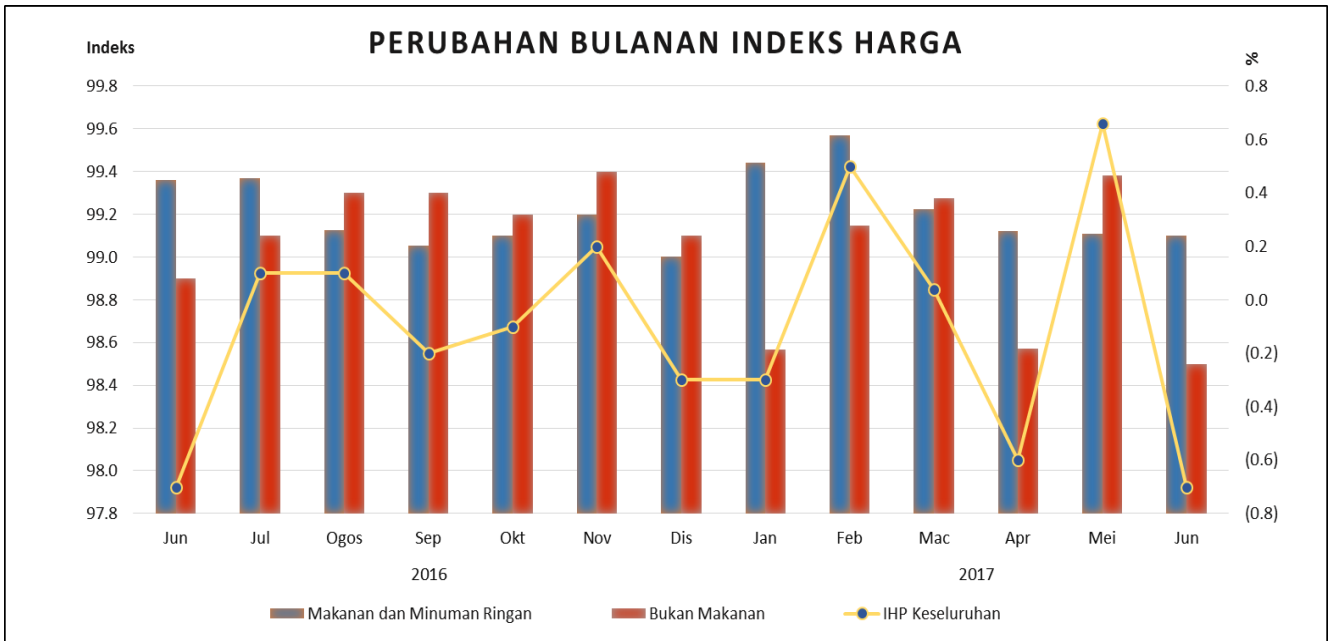

INDEKS HARGA PENGGUNA (IHP), JUN 2017

1. Indeks Harga Pengguna (IHP) bagi bulan Jun 2017 menurun sebanyak 0.3 peratus tahun-ke-tahun berbanding bulan Jun 2016. Indeks Makanan dan Minuman Ringan dan Indeks Bukan Makanan masing-masing mencatatkan penurunan sebanyak 0.2 peratus dan 0.4 peratus tahun-ke-tahun.
2. Penurunan IHP bagi bulan Jun 2017 sebahagian besarnya disebabkan oleh penurunan Indeks Pakaian dan Kasut (7.6 peratus); Perhiasan, Peralatan Isi Rumah dan Penyelenggaraan Rutin Isi Rumah (2.0 peratus); dan diikuti oleh Pelbagai Barangan dan Perkhidmatan (1.8 peratus). Ini adalah berikutan harga rendah bagi pabrik untuk pakaian, kebanyakan pakaian, barangan perabot dan perhiasan, perkhidmatan dandanan rambut serta barangan dan beg perjalanan.
3. Bagi perubahan tempoh ke tempoh, IHP bagi Januari-Jun 2017 mencatatkan penurunan sebanyak 0.4 peratus berbanding dengan Januari-Jun 2016. Indeks Makanan dan Minuman Ringan dan Indeks Bukan Makanan masing-masing mencatatkan penurunan sebanyak 0.8 peratus dan 0.3 peratus.
4. IHP mengukur perubahan harga barangan dan perkhidmatan yang dibayar oleh pengguna dalam satu tempoh masa ditetapkan dan dikumpulkan setiap bulan. Senarai barangan dan perkhidmatan dalam IHP adalah berdasarkan maklumat perbelanjaan purata sebuah keluarga yang diperolehi melalui Kajian Perbelanjaan Keluarga. CONSUMER PRICE INDEX (CPI), JUNE 2017

1. *Consumer Price Index (CPI) in June 2017 decreased by 0.3 per cent year-on-year compared to June 2016. Both Food & Non-Alcoholic Beverages and Non Food Index decreased by 0.2 per cent and 0.4 per cent year-on-year, respectively.*
2. *The overall decrease in CPI in June 2017 was attributed to decrease in the indices of Clothing and Footwear (7.6 per cent); Furnishings, Household Equipment and Routine Household Maintenance (2.0 per cent); and followed by Miscellaneous Goods and Services (1.8 per cent). These were mainly due to lower prices of clothing materials, most garments, furniture and furnishings, hairdressing services as well as travel goods and bags.*
3. *On a period-on-period basis, CPI in January-June 2017 has decreased by 0.4 per cent compared to the same period last year. Both Food and Non-Alcoholic Beverages and Non Food Index decreased by 0.8 per cent and 0.3 per cent, respectively.*
4. *CPI is a measure of price changes of goods and services paid by the consumer in a specified period and compiled on a monthly basis. The list of goods and services in the CPI is based on the average expenditure per household from the Household Expenditure Survey.
